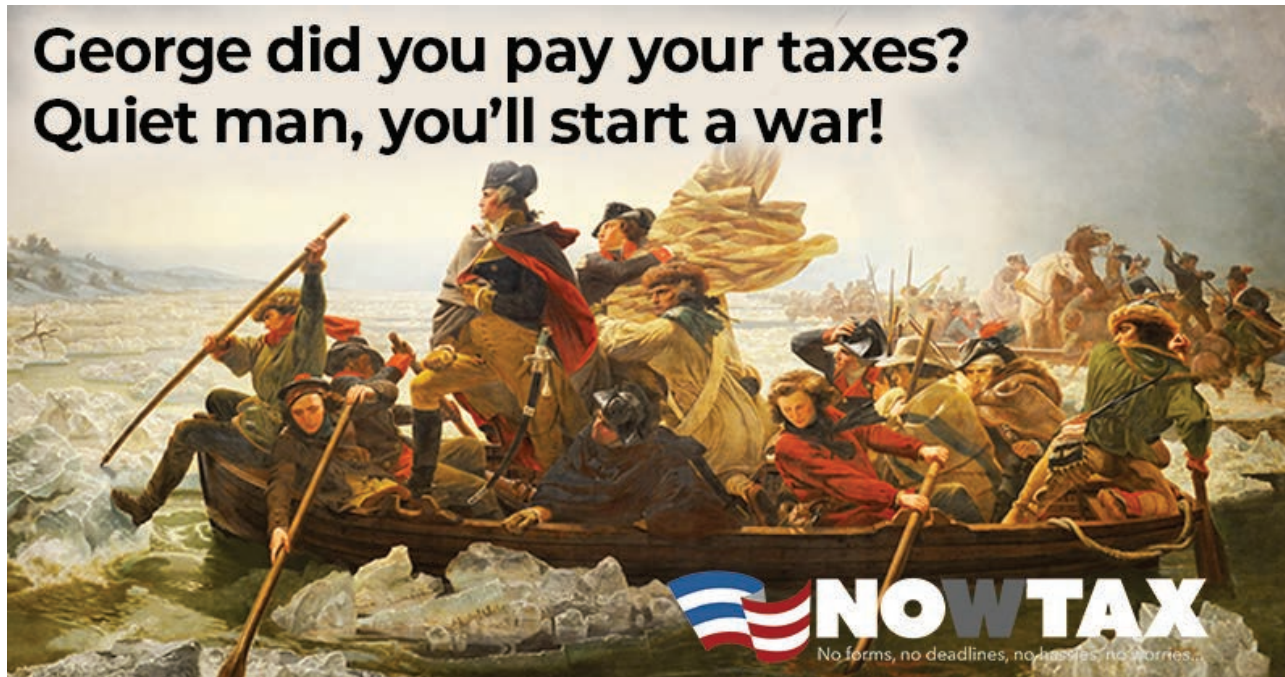

The Morality & Ethics of Taxes

"We hold these truths to be self-evident, that all Citizens are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness."

The Declaration of Independence

"Pursuit of Happiness" - It is not a nebulous phrase that means we can do what we want.

John Locke's, the originator of **"Pursuit of Happiness"**, meaning is: Individual Sovereignty, (the expanded meaning of Locke's property) even without God's endorsement, is the ultimate, inalienable right. The definition of Individual Sovereignty: The quality or state

of being sovereign, or of having supreme power or authority over yourself, your tangible property, intangible property, thoughts, ideas, and sovereignty over no other person. Rightful status, independence, or prerogative. A sovereign or independent person. Simply said, "Every persons' home is their castle".

The original Declaration phrase from John Locke was Life, Liberty, and Estate. **Estate's Meaning is Property & Wealth. Owning property and wealth is the meaning of "Pursuit of Happiness"**.

Note: John Locke's definition of property was in context of Individual Sovereignty, and never included the ownership of people/slavery.

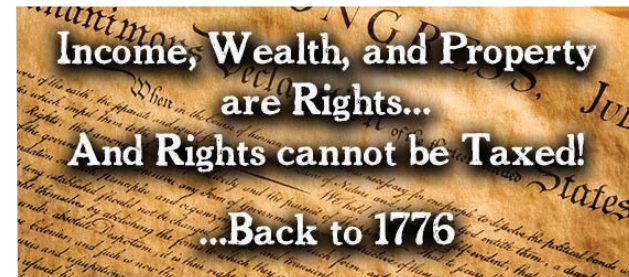
Without Income, Wealth, and Property you have No Rights!

Taxes should be in accordance with the Constitution, Bill of Rights, and the Spirit of the Declaration of Independence.

The following consequential and momentous reasons compel the elimination of our current tax systems and the 16th Amendment.

- Violates the 14th Amendment's equal and fair justice clause:
 - Under penalty of law, some citizens are paying and responsible for an unfair proportion of taxes - An estimated 75 million Citizens pay 97% of Federal taxes. 260 Million pay no income taxes at all.
 - Different tax laws favoring Corporations, Businesses, Taxpayers and Citizens under the income poverty line.
- Income, wealth, and property taxes are extorted and are usurious to Citizens with high tax rates, interest & penalties, the threat of punishment, and wealth & property seizures.

- Violates the 4th Amendment; the right to privacy.
- Violates the 5th Amendment; the right to property.
- Violates the 1st Amendment; Freedom of Speech - Citizens United vs. FEC: Donations (money) given to candidates are considered a form of freedom of speech, therefore, money is a remuneration of speech (the less money the less speech you have, and the more money the more speech you have).
- The current system is unstable, unsustainable and nebulous as it is constantly being modified due to the political policies of legislators and the executive branch.
- Creates an undue burden with over 6871 pages of tax laws, not comprehensible by any common Citizen.
- Creates a permanent state of debt never agreed to by any contract of goods or services provided.



Citizens Tax Bill of Rights

Citizens demand that the burden of taxes be equally and evenly spread across all segments of our society so as to never favor any Citizen, group, organization, business, or enterprise. A neutral, non-regressive, non-progressive, apolitical, nonpartisan, and sole/single system.

Just one tax system a Broad Base - National Sale of Goods, Services, and Financial Transactions Tax.

Never again shall Income, Property, and Wealth be Taxed.

Taxes will never invade the privacy of Citizens.

Taxes will never punish, penalize, or incarcerate any Citizen.

Taxes will be the lowest tax rate possible to have little or no effect on our economy.

Taxes will be limited to the least amount of laws, rules, or regulations.

Automatic with no forms, no deadlines, no penalties, no regulations, no other taxes.
